**General Guidelines for the candidates:**

1. The result of the written test will be displayed on the University/Concerned School notice board on 16.07.2026 by the Chairman, SRC of the respective schools.
2. The Written Entrance test shall comprise of 02 sections i.e. Subject Specific & Research Methodology having a total of 70 marks. The syllabus for written test will be as per GATE/NET examination pattern.
3. Minimum Qualifying marks for written examination are 50%. A relaxation of 5% marks will be allowed in entrance examination for the candidates belonging to SC/ST/OBC/ differently-abled category, Economically weaker section (EWS) candidates.
4. The candidates who qualify the written test and those candidates who have qualified UGC-NET (including JRF)/ UGC-CSIR NET (including JRF)/ SLET/GATE/M. Phil/DST-INSPIRE will be required to appear for a Presentation/ Interview ( 30 marks) before the SRC of the concerned School at AB Committee room in the Administrative Block at SMVDU, where the candidates are required to present their research interest/ area through a 10-12 minutes Power Point Presentation (all candidates are advised to come prepared with their PPT in a pen drive) before the committee..

5. All provisionally shortlisted candidates are required to bring original documents and 02 set of self-attested photocopies (High School, Intermediate, Graduation, Post-Graduation, NET/SLET/GATE/M. Phil, Caste Certificate, etc), in support of their claim as mentioned in the Ph. D. application form at the time of Interview.
6. All the provisionally shortlisted candidates must carry a valid photo identification card like Aadhar/ Passport/Government Id card/ PAN card etc failing which the candidates shall not be allowed to appear in the written and /or interview.
7. Candidates in Government/ Private/ University services seeking admission on part time registration basis are required to submit 'No Objection Certificate' obtained from their employer, at the time of written test/ interview.
8. Candidates seeking admission to Ph. D. on part-time registration basis must have a minimum experience of 02 years as on date of application. Such candidates must declare their preference to the document verification committee before the start of the Interview and must bring NOC from their employer and an Experience Certificate of having minimum 02 years experience. Candidates who fail to bring the above two documents shall not be allowed to appear in the Interview.
9. For any queries, Head of the respective schools can be contacted through their registered email ids and on the contact numbers (Registered email ids and contact numbers are available on the University Website).
10. Outstation candidates desirous of availing Guest House accommodation shall submit their request for booking at [i/cguesthouse@smvdu.ac.in](mailto:i/cguesthouse@smvdu.ac.in) and [jp.singh@smvdu.ac.in](mailto:jp.singh@smvdu.ac.in) atleast 05 days prior to the date of Entrance examination. However, the accommodation in the guest house shall be provided subject to its availability and on payment basis as per University norms.
